# Forest Access Permit

## **ISSUED BY FORESTRYSA**

#### **PERMIT CONDITIONS**

#### Please ensure all people covered by this permit observe the following:

- No access is granted to active operations or outside of the area the permit applies to obey all signage
- No access on days of Total Fire Ban, Forest Closures or outside of the nominated permit period
- No fires to be lit or maintained, REPORT ALL FIRES TO 000
- No interference with plantation crops or removal of plantation products
- Respect other users and neighbours
- Use of any firearm or other weapon is prohibited
- Any activity should not cause any environmental or other damage. OneFortyOne reserves the right to recover the costs relating to any damage caused by the permit holder
- All vehicles must be registered, drivers licenced and remain on formed tracks.
- Treat wetlands, native vegetation, heritage and cultural areas with care and respect.
- Report all incidents or near misses to ForestrySA.
- Prior to an activity you may be required to contact neighbours and inform them of the activity.
- Remove all rubbish and evidence of your activity from the site.
- Do not attach signs, route markers or bunting to trees by nails or wire. All signs must be removed within seven days.
- Any requests or directions made by ForestrySA or OneFortyOne representatives in relation to forest operations and safety must be observed.
- Additional requirements may be requested by ForestrySA or OneFortyOne.
- ForestrySA and OneFortyOne reserve the right to suspend or cancel access to areas of the forest for operational and safety reasons at any time.
- Entry is at the sole risk of the person entering the Lease Area.

#### **PERMIT ACTIVITIES**

#### **Cave diving**

- All bookings must be made and approved through the Cave Divers Association of Australia website.
- Permits must be displayed on vehicle windscreen.
- Vehicles not to be left obstructing emergency vehicle access.
- Pines Cave is a dual rated site, cave level divers must not enter advance level sections of the cave.
- All divers must comply with Australian Speleological Federation (Inc.) Code of Ethics and Conservation.

#### **Caving**

- Cavers must be part of a recognised group that has insurance (e.g. CEGSA).
- At least one person in the group must be appropriately qualified.
- Recreational caving is now restricted to Snake Hill Cave and Morgans.
- Cavers must ensure minimum impact to decorations. Caving in sites where bats are wintering is restricted during those times.

#### Horse riding

- Horse riding is restricted to plantation areas only.
- Horses must be kept away from commonly used picnic areas.
- Hurdles or other structures cannot be erected without permission of ForestrySA.
- Entry is not permitted into areas closed to horses by fences or signs.
- Horse-drawn vehicles must remain on roads/tracks.
- Horses must remain on maintained tracks or trails.
- Note: Horses are prohibited in Native Forest Reserves.
