## **ACCESS CONDITIONS – GREEN TRIANGLE FORESTS**

Activities Not Requiring a Permit for all areas:

Walking, visiting recreational sites, bird watching, personal photography, canoeing and boating - Lake Edward (strictly electric motors only), fishing - Lake Edward (Strictly Redfin ONLY) and low-impact cycling, non-commercial photography, non-commercial activities.

Activities Not Requiring a Permit specific to Plantation areas only:

Access with registered vehicles on dry stable tracks during daylight hours only, walking dogs or pets (must be under the effective control of the owner).

Common minor activities that require a permit:

Christmas tree collection, collection of pinecones or other forest materials, scientific research, seed collection(a permit from Department of Environment and Water is also required), special access to restricted areas (eg. vehicle access for a scientific survey), drone usage, commercial activities and photography. Some activities may incur a fee or charge.

Activities not supported or restricted in the Green Triangle Region:

Camping, fossicking, down-hill mountain biking, fires, vehicles/horses/motorbikes in Native Forest Reserves, vehicles off-tracks, entry on a Total Fire Ban day, firewood collection, activities prohibited with notices/signage, driving unregistered vehicles, entering the forest at night, rubbish dumping, , firearms, shooting, hunting, trapping, pets in Native Forest Reserves, and taking plants, fungi, animals or soil from the forest, entering a restricted area (eg a plantation operation), interference with heritage or cultural sites crops or plantation, damage to trees or infrastructure, activities causing environmental harm.

## Indemnity:

To the full extent permitted by law you release and indemnify ForestrySA, the South Australian Government, OneFortyOne and all officers, agents and public servants from and against all claims, demands, actions, proceedings, judgments, orders, damages, costs, losses and expenses of any nature whatsoever in respect of loss of life, personal injury or disability, loss or damage to property or any other loss whatsoever arising out of or in connection with access to and from ForestrySA managed land, including OneFortyOne Lease areas:

Conditions of Permits – All Areas:

Please ensure all people covered by your permit also observe the following:

- a) Validity: Permits are valid from the date and time selected. Please retain a copy of email confirmation. The bearer of this permit agrees to abide by all conditions specified. ForestrySA reserves the right to revoke this permit.
- b) Tenure: This Permit is for activities on ForestrySA managed land as specified above. ForestrySA managed land includes ForestrySA Native Forest Reserves, Forest Reserves, and OneFortyOne lease areas for which ForestrySA has jurisdiction.
- c) Additional Conditions or Restrictions may be imposed by the ForestrySA Ranger.
- d) Forest Reserve Closure due to fire danger: All ForestrySA Native Forest Reserves and One Forty one Plantation lease areas (including walking trails and picnic areas) are closed to the public on days of Total Fire Ban, as declared by the Country Fire Service (CFS) in the South East region. Forest closures may also occur for other forest operations or fire management-related activities,

- with little warning. Ensure you check weather conditions before arrival, particularly during the Fire Danger Season and visit the CFS website or call the Fire Ban Hotline on 1300 362 361 to stay up to date with current fire bans and restrictions.
- e) Forest Operations: Entering a forest operation area is prohibited. Observe all KEEP OUT FOREST OPERATIONS IN PROGRESS signs. Recreation sites can be closed at certain times of the year due to operations.
- f) Commercial Users: Commercial Users must first obtain a license via the Event Application Form on the ForestrySA Internet.
- g) Rates: Fees and charges may apply. Full payment of is required prior to permit being valid. Fees and charges listed on the website are correct and applicable at the time of registration. Fees and charges are subject to change.
- h) Cancellation ForestrySA: Upon the occurrence of permit cancellation by ForestrySA, ForestrySA shall elect to refund to the purchaser, (minus administration fees).
- i) Cancellation Purchaser: Upon the occurrence of the permit cancellation by the Purchaser, ForestrySA shall elect to refund the purchaser when this is undertaken more than 3 full business days prior to the activity. A cancellation fee of \$5.00 plus administration fees will apply. No refunds are available for cancellations less than 3 full business days prior to the activity.
- j) Camping and campfires are not permitted in ForestrySA's Green Triangle Forest Region. Entering the forest at night is an offence under the Forestry Act 1950 and Forestry Regulations 2013

## Additional Conditions – Plantation Areas

- k) No access is granted to active operations or outside of the area the permit applies to obey all signage
- I) Entry to the forest is at the sole risk of the persons covered by this permit.
- m) No access on days of Total Fire Ban, Forest Closures or outside of the nominated permit period
- n) No fires to be lit or maintained, REPORT ALL FIRES TO 000
- o) No interference with plantation crops or removal of plantation products
- p) Respect other users and neighbours
- q) Use of any firearm or other weapon is prohibited
- r) Any activity should not cause any environmental or other damage. OneFortyOne reserves the right to recover the costs relating to any damage caused by the permit holder
- s) All vehicles must be registered, drivers licenced and remain on formed tracks.
- t) Treat wetlands, native vegetation, heritage and cultural areas with care and respect.
- u) Report all incidents or near misses to ForestrySA.
- v) Prior to an activity you may be required to contact neighbours and inform them of the activity.
- w) Remove all rubbish and evidence of your activity from the site.
- x) Do not attach signs, route markers or bunting to trees by nails or wire. All signs must be removed within seven days.
- y) Any requests or directions made by ForestrySA or OneFortyOne representatives in relation to forest operations and safety must be observed.
- z) Additional requirements may be requested by ForestrySA or OneFortyOne.
- aa) ForestrySA and OneFortyOne reserve the right to suspend or cancel access to areas of the forest for operational and safety reasons at any time.
- bb) Entry is at the sole risk of the person entering the Lease Area.
